BYOD (Bring Your Own Device)
Agreement Policy

Purpose:

Goldsboro Elementary Magnet School has implemented a Bring Your Own Device program enabling students to bring several types of wireless devices for use in the classroom. At home, students are actively using wireless devices to do homework, research projects, read, and communicate with friends, etc. The opportunities to use wireless devices are almost limitless. Students wishing to participate must follow the responsibilities stated in the Acceptable Use Policy as well as the following guidelines.

Device Types:

For the purpose of this program, the word "device" means a privately owned wireless and/or portable electronic piece of equipment that includes laptops, netbooks, tablets/slates, and smart phones capable of accessing the Internet.

Guidelines:

1. Any student who wishes to use a personally owned electronic device within the Goldsboro Elementary Magnet School must read and sign this agreement along with a parent or guardian.
2. The student takes full responsibility for his or her device and keeps it with him or herself at all times. Although every effort will be made to provide a safe secure place for your device, the school is not responsible for the security of the device.
3. The student is responsible for the proper care of their personal device, including any costs of repair, replacement or any modifications needed to use the device at school.
4. Administration reserves the right to inspect a student's personal device if there is reason to believe that the student has violated Board policies, administrative procedures, school rules or has engaged in other misconduct while using their personal device.
5. The student must comply with all teacher requests to shut down the computer, close the screen or secure the device.
6. Cell phone use/texting is not permitted without the approval of the teacher and/or administrative staff.
7. The student may not use the device to record, transmit or post photos or videos of a person or persons on campus. Nor can any images or video recorded at school be transmitted or posted at any time on Social Network web sites such as FACEBOOK or any other web site without the express permission of the Goldsboro Principal.
8. The student will only use their device to access relevant files and web sites as directed by the teacher.
9. The student will use the guest wireless network. Use of 3G & 4G wireless connections is not allowed.
10. Violations of any Board policies, administrative procedures or school rules involving a student's personally owned device may result in the loss of use of the device in school and/or disciplinary action.

As a student, I understand and will abide by the above policy and guidelines and the Seminole County Public School Acceptable Use Policy for Creating Digital Citizens 5.52 (<http://tinyurl.com/csqxm7f>). I further understand that any violation of the above may result in the loss of my network and/or device privileges as well as other disciplinary action. As a parent\guardian I understand that my child will be responsible for abiding by the above policy and guidelines. I have read and discussed them with her/him and they understand the responsibility they have in the use of their personal device.
